VLII Transition Home Expectations:

The VLII Transition program has developed the following expectations for your safety & security. If they are not followed, they could lead to infractions or termination from the program.

An infraction will be issued if the following guidelines are not met:

- Not attending your mandatory meetings. Staff will update you on the dates & times. They will also be put on the calendar, so you will be able to know when they are. No excuses.
- Not cleaning up after yourself or your guests. This includes common areas, hallways, bathrooms & your bedroom.
- Complete house responsibilities. When you sign up for a cleaning checklist taskyou need to do it before 10p that night.
- Keep windows in sleeping areas & common areas <u>closed</u> at night. There are sensors so we will know if they are open. Ask a staff member before opening a window to let in fresh air.
- Dress appropriately when out in common areas & out in public. Comfy clothes are ok to wear at home, but do not wear PJs in public.
- Keep snacks/food in the kitchen area. You have a labeled cubby in the pantry to keep your personal snacks. **DO NOT TAKE OUT OF OTHERS' BINS.**
- No tampering with thermostats. Ask staff for assistance.
- No hair dyeing, unless at the salon with a professional.
- Not providing verification of appointments, work/school/activity schedules.
- Residents <u>CAN NOT</u> be in other residents' rooms without that resident present.
 Door must be open if you decide to hang out together.
- Not attending required classes, as decided by the program.
- No returning home by your set curfew.
- No vaping, smoking/tobacco use, no alcohol/drug use, no mind- or mood-altering substances (that are not your medications).
- You must return home sober.
- You must leave the building during a fire alarm.
- You must be respectful of other residents, staff & volunteers. This includes no gossiping about others, name calling, racial slurs, jokes or gestures is not allowed. Our mission includes eliminating racism wherever it exists. If a racial slur or joke is made, the resident will be required to meet with case manager to discuss what racism is & how it affects others. You will be terminated from the program if there are any other racial comments after this.

- Storing and/or "cheeking" your medication is not allowed. Failure to not take medication as prescribed/directed is not recommended. If you decide to not take your meds, you will meet with your case manager & provider to discuss options.

You may be asked to leave for the following zero-tolerance violations:

- Breaking confidentiality. You may not mention other residents' or staff names during or after you stay at the program. Do not talk about other residents' personal lives to other people.
- Having a weapon, alcohol, or illegal drugs in the building or on property.
- Stealing or destroying another's property.
- Disrespecting the other residents or staff, the use of excessive foul language, racism/sexism or threats will **NOT** be tolerated.
- Allowing others into VLII without staff knowledge.
- Smoking, use of drugs/alcohol & using/storing/hiding it within VLII property.
- Playing with/unplugging any smoke directors, door locks/codes, or security systems.
- Committing any violent or abusive acts or behavior, on or off VLII property, during your stay.
